TERMS AND CONDITIONS AND NOTICE TO CONSUMER

By agreeing to receive your account statement notification electronically by a secure encrypted email instead of receiving a paper copy of your statement through the U.S. Postal Service, you are agreeing that:

1. You have access to a computer that has Internet Explorer 6.0 or higher, a valid email address, and your computer is capable of receiving Portable Document Format (PDF) files with Adobe Acrobat 5.0 or higher.
2. As an account holder, you are electing to receive online e-statements or change the statement delivery method on behalf of all owners of this account. You will be required to provide the Bank written authorization to change the statement delivery method.
3. Only persons who are Account Owners, Power of Attorney, Guardians or Custodians may authorize Online E-Statements or changes in statement delivery.
4. If you elect to receive online e-statements, you will no longer receive a paper statement mailed through the U.S. Postal Service.
5. You are responsible for viewing, printing and saving your electronic statement for future reference.
6. You are responsible for adjusting or correcting any local software or Internet Service Provider (ISP) issues such as SPAM filters, browser settings, firewall or other security programs which may filter out emails or that might remove or block your Online E-Statement.
7. You will notify the Bank of Salem should your e-mail address change. You may notify us at it@thebankofsalem.com or by calling 573-729-3137 or by surface mail at Bank of Salem, P.O. Box 459, Salem, MO. 65560.
8. Your Online E-Statement delivery will be terminated if your email is returned to us three (3) times or more for any reason. Once terminated, paper statement without check images delivery will resume and a \$5.00 "undeliverable E-Statement" fee will be charged to your account.
9. The Bank reserves the right to change the hardware or software requirements for Online E-Statement delivery. The Bank will inform you and you may withdraw your consent to receive your periodic statements electronically, without any fee for withdrawal of such consent.
10. To change your periodic statement delivery method, you must complete and sign and return to the Bank the Online E-Statement Enrollment Form.
